

Dear parents and guardians,

Many young women are very talented in mathematics and technical and science-orientated subjects and their grades in these areas are often similar to those of the boys. Despite this, incorrect assumptions concerning professions and genders often mean that many young women considerably restrict their choice of career and choose (trainee) careers in which predominantly women work e.g. shop saleswoman, office worker or hairdresser / wig maker. In contrast, apprenticeships or study courses in the manual, technical and science-orientated fields are rarely chosen yet these offer significantly better income and career opportunities and greater opportunity for development.

The Girls' Day offers your daughter the special opportunity to gain experience, also practical, in future-orientated work environments, strengthen interests, skills and talents and also discover new insights about herself. Participation in the Girls' Day supports pupils in setting themselves wider goals, taking their own path also beyond the traditional roles, and in choosing from a wide range of more than 200 apprenticeship professions and numerous MINT study courses.

For this, around 70 businesses and educational facilities throughout Tyrol will open their workshops and laboratories to pupils for the Girls' Day and will offer an interactive programme. The Girls' Day will give your daughter an impression of the immense diversity of the professional opportunities which are open to her which will also act as orientation aid in her successful choice of career.

The Girls' Day on 24 April 2025 will take place for the 24th time in Tyrol and is a **school-related event**. Your daughter will be insured during the time she spends at the company of her choice.

Please note

- Pupils do NOT visit a company as part of a class but, instead, choose a technical, manual or science-orientated profession and then familiarise themselves with this on the Girls' Day.
- Each company will offer at least two places on the Girls' Day. Pupils therefore spend the day with a company with at least one other pupil.







How can you help your daughter?

- Help your daughter choose the technical, manual or science orientated profession she would like to learn more about at the Girls' Day. You can find further information on these careers on the Girls' Day website on: www.girlsday-tirol.at/berufsliste. Note: Please also note where the company in which your daughter would like to learn more about her chosen field is located as pupils must travel to and from this by themselves. Transport will not be arranged.
- 2. Plan the journey to and from the company/educational facility which your daughter will visit on the Girls' Day together. For pupils who do not have the "Schulticket Tirol" (or other ticket for free use of public transport) the Girls' Day Tirol will offer, in association with the VVT and IVB, free transport to and from the company. Your daughter can get her ticket for 24 April 2025 Girls' in April 2025 via Day Tirol website. Note: This is only valid in association with the Girls' Day Tirol participation confirmation which your daughter will receive after registering in March. Your daughter will receive all further information on the free ticket in advance.
- 3. Discuss your daughter's expectations of the Girls' Day with her as well as any questions she would like to ask the company/educational facility. Go through the day's schedule with her.

With good preparation you will help your daughter gain confidence so that nothing will stand in the way of a great day full of new experiences and impressions!
